NOTICE OF PUBLIC HEARING

The Cottle County Commissioners Court will conduct a public hearing at its regularly scheduled meeting on to consider and to act upon the following items: (1) to consider the application of Thalia Solar, LLC, for the designation of a certain area of Cottle County, Texas, as a Reinvestment Zone for Tax Abatement to be known as the Cottle County Reinvestment Zone-Thalia establishing the boundaries thereof, and providing for an effective date; and (2) to consider accepting an Application for Tax Abatement for Cottle County to enter into a Tax Abatement Agreement with Thalia Solar, LLC, pursuant to the provisions of the Property Redevelopment and Tax Abatement Act, Chapter 312 of the Texas Tax Code. This project will produce approximately 252 MW of solar generated power, with an associated 100 MW of battery storage capacity, at an estimated cost of \$241,600,000.00.

In determining whether to designate the Reinvestment Zone, the Commissioners Court will consider whether the Reinvestment Zone described meets the criteria set forth in Texas Tax Code §312.202 for the creation of a reinvestment zone as set forth in the Property Redevelopment and Tax Abatement Act, as amended, in that the designation would contribute to the retention or expansion of primary employment or would attract major investment in the zone that would be a benefit to the property to be included in the zone and would contribute to the economic development of Cottle County. In determining whether to accept the Application for Tax Abatement, the Commissioners Court will consider the Application in light of the criteria in the Cottle County Guidelines and Criteria, as in effect or as may be adopted at the public hearing.

The public hearing will take place at 9:00 a.m. on August 28, 2023, at the Commissioners Courtroom, Cottle County Courthouse, Cottle, Texas 79248. All interested persons may appear and present testimony and evidence regarding designation of the Reinvestment Zone and acceptance of the Application for Tax Abatement.
