I, JOHN B. SCOTT, SECRETARY OF STATE OF THE STATE OF TEXAS, DO HEREBY CERTIFY, in accordance with Section 274.003 of the Texas Election Code, the following amendments are the proposed constitutional amendments as submitted by the 87th Legislature, Second Called Session and 87th Legislature, Third Called Session, to appear on the constitutional amendment ballot for the special election to be held May 7, 2022.

STATE OF TEXAS PROPOSITION 1

"The constitutional amendment authorizing the legislature to provide for the reduction of the amount of a limitation on the total amount of ad valorem taxes that may be imposed for general elementary and secondary public school purposes on the residence homestead of a person who is elderly or disabled to reflect any statutory reduction from the preceding tax year in the maximum compressed rate of the maintenance and operations taxes imposed for those purposes on the homestead."
