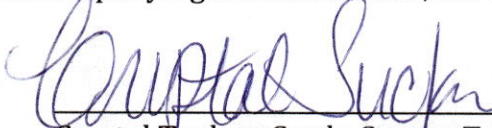

County of Cottle Commissioner's Court Affidavit FY 2026 Monthly Report June 30, 2026

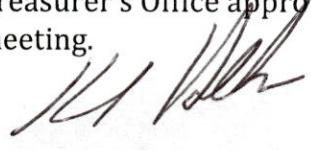
