

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.8130 per \$100 valuation has been proposed by the governing body of Cottle County.

PROPOSED TAX RATE	\$0.8130 per \$100
NO-NEW-REVENUE TAX RATE	\$0.7396 per \$100
VOTER-APPROVAL TAX RATE	\$0.8864 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for Cottle County from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that Cottle County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Cottle County is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 22, 2022 AT 9:30 AM AT Commissioners Courtroom, Cottle County Courthouse, 815 9th Street, Paducah, Texas.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Cottle County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioners Court of Cottle County at their offices or by attending the public hearing mentioned above. YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by Cottle County last year to the taxes proposed to be imposed on the average residence homestead by Cottle County this year.

Average homestead taxable value	\$28,700	\$31,186	increase of 2,486, or 8.66%
Tax on average homestead	\$233.33	\$253.54	increase of 20.21, or 8.66%
Total tax levy on all properties	\$1,339,912	\$1,477,037	increase of 137,125, or 10.23%
